The non-availability of migrant workers is interrupting some harvesting activities, particularly in Northwest, India. Where wheat and pulses are being harvested. There are disruption a supply chain because of transportation problems and other issues. The prices of wheat vegetable, fruits and other crops have declined, yet the consumers are paying more charges. It is the economic loss of farmers as well as consumers. In the konkan region with the Alphonso mango season just **starting** at nearly 40 % production is sent to foreian countries. Due to clouser of export farmers will suffer a huge economic losses.

4.1.2 Hotel Industry :-

The hospitality industry is a broad category of field's within the service industry, that includes lodging, food and drink service, event planning, theme park, travel and tourism. It includes Hotels, tourism agencies, restaurants and bars.

Hotel industry say's it lost is Rs. 1.3 trillion revenue in FY 2021. The Indian hotel Industry has taken a hit of over Rs. 1.30 lakh crore in revenue for the fiscal year 2020-21 due to the impact of Covid-19. The Indian hotel industry total revenue is F. Y 2019-20 stood at Rs. 1.82 lakh crore. As per our estimates in the F. Y 2020-21 approximately 75 % of the industry's revenues got wiped off. The hotel business are steadily closing and non-performing assets (N. P.A) are rising. Since march 2020 the industry has been struggling to manage its statutory and capital expenditure. The repayment of loan with interest is not just difficult but impossible under severe economic environment do to the present surge.

4.1.3 Poultry Industry:-

India is one of the world's largest producers of eggs & Chicken. India is the third- largest egg producer in the world (after China & U. S.) and fourth largest chicken producer in the world. It is estimated with a poultry population of 729 million small and medium farmers are mostly engaged in contract farming system. The poultry Industry is situated in different part of the country has been hit hard and remours but the covid-19 can transmitted through consumption of Chicken, the prices of chicken have declined considerably as a result, near about two crore peoples employed in the poultry industry across the

The demand for the two wheeler and four wheelers vehicle drastically reduced in the lockdown period. After ease of lockdown also there no mejor growth in the demand of auto industry. Lockdown reduces the income of middle income group in India. Which results in declined the demand of auto industry. Indian companies will vary and depend upon the extent of the business with China. If shutdown is continues then it is expected to result in an 8-11 % Contraction of Indian auto manufacturing in 2020. .

Auto dealers have faced major problem at present there are 16000 auto dealers which include two, three and four wheelers across India. They were not able to transport vehicles in the lockdown period. The Covid-19 also affected automobile new Vehicles sales very badly especially in the month of Feb.2020. Like, in china new sales of Vehicles have fallen by 92 % in the Feb. 2020.

4.1.5 Travel, Tourism and Transport Industry :-

In India tourism is very important for the country's growing economy. Travel & tourism industry is an integral pillar of the make in India programme. The sector plays a significant role as and economic multiplier in creating Job at rapid rate. But due to Covid -19 this sector also affected. The negative impact have prevailed these industry.

Travel, tourism and Transportation (TTT) are few most critically victimized sector of Covid-19. As the rickhow puller to airlines all have been affected the demand of TTT sector is adversely hit. The public transport such as railway metro airlines, taxis and buses are act as a carriers & distributor of disease and well harshly pretended by unremitting rules of social distancing. It can be also observed that due to the limited operation of the pubic transport system in the lockdown period, severe losses have been incurred in all the modes of public transport. The Indian railway will loss Rs. 6000 crores to Rs. 12500 crores from passenger trains & Rs. 6000 crores for freight service. So it is very big loss of government side.

4.1.6 Dairy Industry :-

The Indian dairy industry is the worlds largest small holder milk production system producing 187.7 million tonners (M.T.) of milk where about 70 % of the milk is produced by small holder having 1-3 animals per household. But in the early day's and months of Covid-19 Pandemic, the dairy industry faced various problems, such as shift in supply and demand. In India all dairy industries struggled to adjust to the new normal during the early stages of the pandemic, most capitalised on increased retail demand through operational flexibility. The dairy supply chain has been mejorly impacted by the covid-19

pendamic. Due to the announcement of 21- Days lockdown has impacted liquid milk consumption by around 30-35 % with the closure of the hotels, restaurants, canteen and sweethome shops etc. .. Consumer are demanding more milk for stock up, hence the shopkeepers have raised the prices of milk.
